

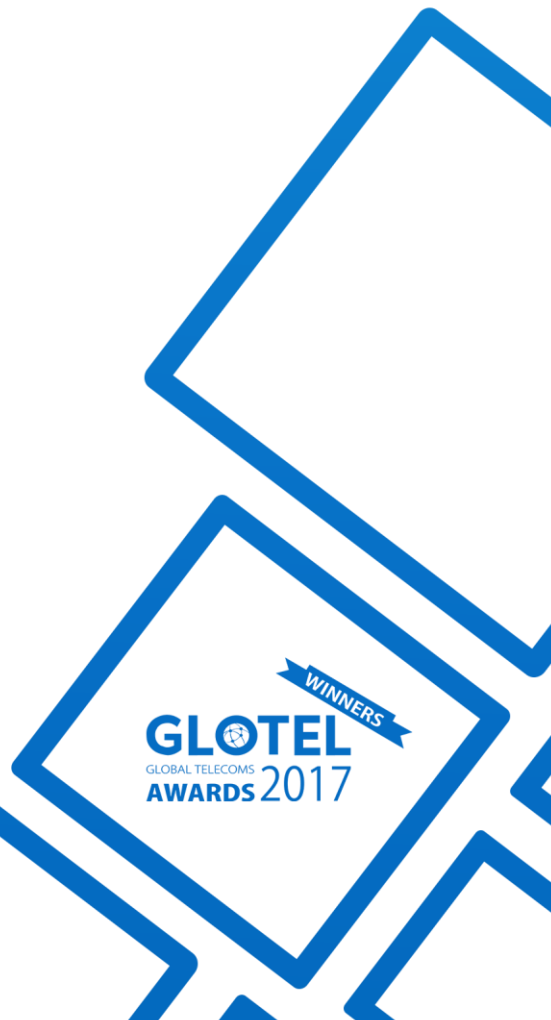

# 1 Privacy Notice

This notice discloses the privacy practices for [www.metricell.com](http://www.metricell.com) and is served by: Metricell Ltd which is headquartered at The Big Blue, 26 Foundry Lane, Horsham, West Sussex, RH13 5PX.
